MannKind Corporation (MNKD) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each MNKD Common Share will be converted into the right to receive 0.20 (New) MannKind Corporation Common Shares. The reverse stock split will become effective before the market open on March 3, 2017.
